1. **Purchase of Tender Document:** The Tender Document can be purchased only online from <http://mptenders.gov.in> by making online payment of the cost of Tender Document and service charges through net-banking, cash card or ATM-cum-Debit Card as per Key date
 2. **Submission of Tenders:** The Bids shall be submitted **online** in 3 Envelopes as follows: -
 - **Envelope 'A'**- on line payment receipts of cost of tender document and EMD and eligibility documents.
 - **Envelope 'B'**- 'Technical Proposal' containing all the technical details, specifications of the proposed work, terms and conditions, tentative drawings, diagrams etc. in clear and exhaustive manner. 'Annexure- F' shall also be submitted **online** in this envelop.
 - **Envelope 'C'**- 'Financial Offer' (also called 'Financial Bid') containing lump sum Financial Offer in words and figures.
- 1) **At the time of submission of the Bid (Envelope "A") the eligible bidder shall be required to submit:**
- a. Receipt of payment of Bid Document.
 - b. Receipt of payment of Earnest Money Deposit. Scanned copy of EMD instrument shall be uploaded online along with the reference details.
 - c. Submit a check list.
 - d. Organizational Detail as per Annexure - H
 - e. P.A.N & G.S.T. Registration Certificate

- f. Submit online affidavit on non-judicial stamp of Rs. 200/- Duly Notarized in original saying that all submitted / uploaded documents with technical bid online are correct in my knowledge & No relationship certificate between dept. employee & officer with him.

2) Eligibility Criteria: (Envelope "B") (documents related to clause 5. Minimum Eligibility Criteria must be submitted under this)

- a. CVs and List of Key Personnel and Engineers under employment.
- b. Power of Attorney in favor of authorized Signatory or Representatives etc. as may be required.
- c. Details of Works in hand giving Name of Work, references of Work Orders, Agreement, Value, Period of Completion etc. duly certified by competent authority.
- d. Undertaking in Annexure-B.
- e. Other relevant documents.
- f. The Bidder Must Submit **OEM Ink signed MAF/ Authorization** mentioning tender details for the **Data Visualization Interface and similar Ink signed MAF is to be submitted for every OEM for which the bidder has submitted the offer for hardware and software under this tendering process.**
- g. Bidder has to make sure that OEM Ink signed compliance confirmation on OEM letter head for the entire solution including hardware and software , solution drawing and design should also be submitted to confirm line items and services offered under this bidding process
- h. Bidder has to submit Ink signed confirmation from **Data Visualization Interface OEM** letter head that **OEM has its own registered office in MP from Last 5 years , supporting document like GST certificate , Gumasta or any document issued by the MP Govt. confirming that OEM has the establishment in MP from last 5 years , These certificates should be issued on the name of OEM, OEM should give confirmation / undertaking that DVI OEM has min 20 service centers in MP to provide immediate service support to the offered setup.**
- i. **DVI OEM should have the Min Turnover of 100 Cr. in last 3 years self-attested supporting document are to be submitted by the bidder.**
- j. Bidder has to submit valid IAFcertsearch.com registered/Issued ISO9001/ 14001, ISO 45001 for the offered external Power backup device OEM.
- k. Bidder also has to submit the undertaking on the OEM letter head confirming that the offered external Power backup device has the cybersecurity certification to confirm compliance for SNMP& CMS Software as per the ISA/ IEC Standards, OEM's self-attested copy of the certificate is to be submitted.
- l. The bidder must submit work completion or supply certificates.
- m. To prove financial eligibility, the bidder must submit audited financial statements or a Chartered Accountant's certificate showing **an average annual turnover of at least ₹10 crores for FY 2022-23, 2023-24, and 2024-25.** Copies of Income Tax Returns for the same years should also be provided.
- n. The Bidder Should Have a **positive Net Worth** at the close of the financial year immediately preceding the Bid Due Date. (Certificate from Chartered Accountant should be submitted for verification.)
- o. The department will have technical presentation of the solution prior to opening of financial bid and department can reject the submitted proposal in case it do not meet technical functionality / parameters under bidder scope of work.

3) Earnest Money Deposit (EMD):

- 3.1 The EMD shall be in the form of on-line transfer into the given scheduled bank account

given in the bid data sheet. The details of on-line transfer receipt should be submitted in envelope A.

3.2 Bid not accompanied by EMD shall be liable for rejection as non-responsive.

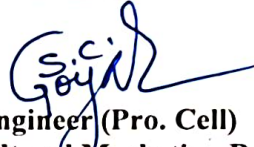
4) Procedure for online submission of Tenders:
