Sir/Madam,

I am directed to inform you that 6 new features have been added on eNAM portal (Annexure 1). These features will help the users and stakeholders to improvise the usage of the software and speed up the transactions. These features have been made live on 3/5/2019 and can also be viewed on What's New sections on http://enam.gov.in. We are advising Strategic Partner (NECL)'s State coordinators who will be conducting a demo session for yourself and the Mandi executives to update on usage of the same.

Further for capturing Non eNAM Trade Data on e-NAM portal, the format is also being sent with the letter which has been made live on eNAM portal on 15th November 2018, steps for non e-NAM Trade data entry capturing of lot-wise e-NAM and non e-NAM Trade electronically would have the following advantages for the Mandis and State Agriculture Marketing Board (Annexure 2)

- No dependency on Physical Auction Register (Physical Record Keeping)
- Real-time information of Total trade in the Mandi.
- Trade Analysis/Business Intelligence based on data uploaded.

Accordingly you may advise all the e-NAM Mandis in your jurisdiction to upload non e-NAM trade data on a regular basis.

Annexure 1: New Features - eNAM

e-NAM Shopping cart-

e-NAM Shopping Cart is a way to create a temporary list of Lots by adding them to cart. Lots can be added for bidding purpose that will make bidding process convenient and also trader can bid in bulk as per their selection/choice.

Discounts to Traders at the time of e-Payment

To promote online payments on e-NAM, various state governments had come up with discounts on digital transactions. To avail this facility, application administrator can configure desired discount percentages in the application. On selection of e-Payment mode by buyer, configured discount facilities will be automatically applicable in the transaction. This discount in Mandi fee will be applicable only in e-Payments.

Logistic Information Module

c-NAM portal provides module for Logistics service providers to create their profile and upload data such

Name/Address/Contact, Annual Turnover, Vehicle Type, Rates per Km, and Region of service etc. Further this feature would help service seekers also to allow them to rate the services also in future.

Bunching of multiple invoices

This trader friendly feature will reduce multiple transaction cost by bunching of selected invoices for single payment purpose. This feature is applicable for Inter-mandi and interstate Invoices also. Single transaction will reduce multiple transaction time for traders.

Auto Sale Agreement

Auto sale agreement will reduce e-NAM workflow execution time and reduce Farmer's transaction waiting time. After weighment is done, auto sale agreement feature will generate Sale agreements.

Unified trading licensing system for Inter State

Trader can apply for interstate trade permission through their e-NAM login. On approval of request by respective State / APMC administrator, trader can participate in trade for both the states simultaneously. State/APMC administrator can track such interstate request and further trade by the trader.
